- Approval of School Improvement Plans
  - The Board approved the School Improvement Plans for Kimes, Centennial and Northlawn as presented.
  
- Approval of Renewal of Health Insurance
  - The Board approved the Health Insurance as presented.
  - Insurance rates will increase 3% starting in January and we will remain with Blue Cross/Blue Shield.
  
- Approval of Dental Insurance
  - The Board approved the Dental Insurance as presented with an increase in those rates as well.
  
- Approval of Workers' Compensation Insurance Renewal
  - The Board approved the Workers' Compensation Renewal with Illinois Public Risk Fund as presented. The rates will decrease 2.77% for the District.
  
- Approval of Release of Bids
  - The Board approved the release of the bids for a new freezer for storage of food for the kitchen.
  - This will more than likely not be onsite until Summer of 2022.
